3.1. Approval of Minutes from February 22, 2023 Meeting

3.2. Business Arising from the Minutes

4.1. Rezoning Review NS-23-010-RZ PID 141366

Development Officer Mirko Terrazas presented application for PID 141366 to rezone from Agricultural to Residential. This file was with the Province for numerous years but was never approved. Discussion amongst committee members regarding adjustments required to meet bylaw requirements.

4.2. Preliminary plans for temporary structures at Stanhope Golf Course

Development Officer presented preliminary plans for permanent and temporary structures at the Stanhope Golf Course. 2 Mobile units for pro-shop/lounge, 1 mobile unit for bathroom, connected to existing septic, 2 food trailers and 1 tent. Temporary for duration of golf season only. This plan shows the trailers being close to the water which will be revisited. Council requested more information be gathered on food trailers and that there be clear dates for the trailers to be removed. Committee members in attendance agreed that the Tim Hortons trailer, in addition to a food trailer, is not necessary to get the Golf Course operational.

It was duly moved and seconded that: that the Tim Hortons trailer be removed from the preliminary plans for the Stanhope Golf Course application for temporary trailers.

4.3. Information regarding possible implementation of Unsightly Premises Bylaw:

CAO presented process of current Unsightly Premises Bylaw, which is enforced by the Province. The cost to enforce is bylaw is the responsibility of the enforcement body. CAO was advised that complaints need to come from the residents of the municipality and not from the municipal office staff members or Councillors. Committee will let residents know how the process works when approached.
